- 2. That the name of the Trust shall be **"AL-FURQUAN EDUCATIONAL AND CHARITABLE TRUST"** (hereinafter called the "Trust")
- 3. That the Registered Office of the Trust shall be situated at **Mazar Chowk, Pilkhana Road, Mohiuddipur, P.O+P.s-Kishanganj, Dist-Kishanganj, Bihar 855108** or such other place or places as may from time to time, be decided by the Trustees.

4. **AL-FURQUAN EDUCATIONAL AND CHARITABLE TRUST** is a public charitable trust. It is established with a vision of "to Create the ambience with Fragrance of love & brotherhood among the people of India, to fulfill an aim of "to improve the qualities of basic necessities of life, in the field of Health, Education, Livelihood & Poverty (HELP) among the needy & poor people and purifies the soul of rich & pious people in society" with the objectives of "all activities of **AL-FURQUAN EDUCATIONAL AND CHARITABLE TRUST** will be done towards the needy and poor people for the sake of love with Almighty thorough the help of good doers". **AL-FURQUAN EDUCATIONAL AND CHARITABLE TRUST** works under the guidance of Trustee and Trust Board member with scholars who ensure that the charity's role as a trustee is always fulfilled, Knowing that we are all ultimately accountable to the Almighty, the charity strives to maintain transparency and accountability.

5. **THE AREA OF OPERATION:**

The area of operation of the Trust shall be **All Over India** to serve the people of India and it could have its branch offices at any place in India or abroad.

- 6. Those who are the Trustees for the purpose and declare that the Settler will continue to be the Managing Trustee/President of the Trust and one of the Trustees for his life time.
- 7. That the ownership, management and control of the trust properties shall be vest in the Board of the Trustees. The above mention Trustees shall be members of the first Board of Trustees and shall also be called and referred as Founder Trustees.

8. **IRREVOCABLE:** That The Trust is irrevocable.

9. **MANAGING TRUSTEE:**

The Managing Trustee shall have all the powers of managing the Trust and its properties, sign documents, statements, affidavits, declaration, returns etc. The Board of Trustee shall have one Chairman. The first Chairman shall be **SYED SHAMSUDDIN** who shall preside all over the meeting of the Board of Trustees and shall be the Principal Executive office of the Trust and shall hold the office of the Chairman for life time. During his lifetime he may nominate one Trust -cum -Chairman as his successor in office.

The Trustee -cum Chairman so nominated shall enter the office after the lifetime of the Present Chairman. If the present Chairman fails to nominate his successor, after his lifetime the remaining Trustee shall elect one amongst, them-selves the next Chairman. For the Trust, appoint, transfer and terminate employee, open and operate Bank Accounts and attend to the day to day management of the affairs of the Trust. He/She shall represent the Trust in all matters before all authorities, courts, Government Departments and all bodies. He/she shall do any act, deed or thing necessary for carrying out the objects or works of the Trust subject to the directions of the Board of Trustees. Any other person may be authorized to do the same.

10. THAT THE MAIN OBJECTS OF THE TRUST ARE:-

A. EDUCATION

- i. To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- ii. To establish, develop, run, maintain and grant aid in cash or in kind to schools, medical colleges, law College, nursing institutions, dispensaries, mobile dispensaries, maternity homes, child welfare centers and/or such other similar charitable institutions in India for the benefit and use of the general public
- iii. To start, establish, run, take over or manage and maintain the schools, with the object to provide Sound Nursery, Pre Primary, Primary, Middle, Secondary, Senior Secondary and Higher Education to children / students by seeking recognition and affiliation from the Education Departments etc
- iv. To offer prizes in cash or in kind and grant scholarship to deserving students and also to provide all possible facilities to the students.
- v. Establishment and maintenance and support of Hostels and/or Boarding Houses and grant of free Boarding and Lodging to poor and deserving students upon such terms and for such period in each case as the Trustees think fit | irrespectively of religion or caste.

- xxii. To erect, construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop, manage and control all or any part of the property or the building of the above Trust, necessary or convenient for the purpose of attainment of the aims and objects of the Trust.

xxiii. To contribute for the construction of any community hall, dharma Sala, hostel, boardinghouse, library, reading rooms, wedding hall etc., for use by the general public.

xxiv. To publish Books, Charts, Illustrations, Journals, Magazines, Periodicals, News Letters/ Papers and other publications in the different languages and on the different subjects

xxv. To assist and co-operate the other Associations, Trusts and various N.G.Os whose aims and objects are commensurate with this Trust.

xxvi. To do such other things / acts / activities which are necessary and which may be incidental or conducive to the attainment of any of the object of the Trust.

xxvii. The activities and the branches shall spread all over in India.

xxviii. The Trust will invest its money and funds according to the Section - 11(5) of the Income-Tax Act, 1961.

11. POWER FUNCTIONS OF THE SETTLER/PRESIDENT:

i. The Settler may appoint any person as employee, manager, supervisor, legal advisor and legal assistant, accountant, cashier, peon, chowkidar etc. He shall have also the powers to terminate the services of any staff as he may deem fit and proper for the benefit of the Trust.

ii. The Settler shall have the power to cast two votes in the case of tie or in difference opinions, decisions, understanding or any disputes arises amongst the Trustees regarding any issues on behalf of the Trust.

iii. The Settler may delegate his/her power to the board of trustees or the committee of the trustees.

12. POWER FUNCTIONS OF THE SECRETARY:

- iv. The Secretary will convince all the meeting of the trust as per the instructions of the President. Date of meeting will be fixed by him.
- v. He shall prepare, spend of a meeting under the direction of the President.
- vi. He shall maintain the office and all registers of the trust under the supervisions of the President.
- vii. He should get the accounts audited according to rules.
- viii. He should deposit in the bank all the collections made as soon as possible

13. POWER FUNCTIONS OF THE TREASURER:

- ix. The treasurer will act under the direction of the committee.
- x. Any amount exceeding Rs. 10000/- which is not required for immediate use shall be paid into such bank or banks as may be approved or by the committee. The treasurer shall ordinarily receive all payments and disburse the amount passed by the president/Secretary and shall maintain proper books of accounts.
- xi. Treasurer shall maintain the account in proper and prescribed form. He shall deposit and withdraw the amount of the trust in the bank or in the post office with the signatures of any two of the secretary, president or treasurer

14. FRAMING OF RULES AND BYE LAWS:

The Trustees may frame Rules and Bye laws for the management of the Trust, its properties, institutions, personal staff and amend or rescind them as they deem fit.

15. REGISTER OF MEMBERSHIP:

A register is the form prescribed by the board of management will be with their age, occupation and full address which will be seen in the office during office hours.

16. CATEGORIES OF MEMBERSHIP:

There shall be three kinds of membership:-

- (i) General Member.
- (ii) Patron Member.
- (iii) Honorary Member.

17. MEMBERSHIP:

- (i) The membership of the trust shall be opened to all men and women who have attained the age of 21 years and subscription and fees and must be citizen of India.

- (ii) An application for membership shall be made in the prescribe form to the PRESIDENT / SECRETARY of the board of management and the paid shall take a decision in the matter of his / her admission to membership and their decision shall be final.
- (iii) Every member shall be bound by the rules and regulations of the trust

18. BOARD OF TRUSTEES:

The Board of trustees shall comprise of maximum 21 trustees and minimum of 7 trustees including the Settler. The Settler shall be managing Trustee for life. The vacancy on board of trustees shall be filled in by the managing trustee in his discretion for such term as stipulated at the time of their appointment.

The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

The Board of trustees may constitute committee/committees to make the trust functional or more transparent.

The managing trustees/settler for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being considered proper. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

19. POWER, FUNCTION AND DUTIES OF THE BOARD OF TRUSTEES:

For the furtherance of the objects of the trust and subject to the provisions of Income Tax Act, 1961 and any other law applicable to the Trust for the time being in force, the trustees shall have the following power, function and duties:-

- i. All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- ii. The general management and control of the Trust properties and its affairs shall be vested in the trustees and the trustees shall have power to do such acts as may be considered necessary for the benefit of the trust and / or management of its properties and affairs. Veto Power shall always remain with Settler, Nominees or the Successor (s).

- iii. To appoint employees and to settle the terms of their service, remuneration and termination
- iv. To invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and immovable properties subject to the provision of section 11(5) of Income Tax Act'1961.
- v. To sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same;
- vi. To pledge or mortgage the trust properties for raising loans;
- vii. To open Bank account/accounts in the name and on behalf of the trust and to operate the same;
- viii. To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- ix. To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed
- x. To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- xi. To seek legal opinion of lawyers and/or Chartered Accountants as and when required;
- xii. No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.
- xiii. If any trustee dies or retires or becomes incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustee.
- xiv. To acquire purchase, vary, sell convey, change, transfer, transpose or otherwise deal with all or any of the investments including shares, stocks, debentures, Govt. Securities belonging to the Trust or representing the Trust Fund/and to re-invest the same as the Trustees may deem fit and proper in accordance with the provisions of Income Tax Act.

- xv. To apply and get registered under Section 12A, 80 G of the Income Tax Act.
- xvi. To accept donations, contributions, gifts and / or other grant-in -aid either in money or in kind.
- xvii. To receive CSR fund from corporate and others.

- xix. To receive financial and non-financial assistance from Govt. , Non- Govt. Organization, NGO , Trust and from any other legal or corporate entities.
- xx. To receive financial and non-financial assistance from International Agencies, International organization, International NGO, banks or any other legal entity or from individual subject to the provisions of Income Tax Act, 1961 and any other law applicable to the Trust for the time being in force.
- xxi. To enter into any contract and borrow money for the purpose of the Trust and management of its properties and assets.
- xxii. To institute suits , actions and legal proceedings , to prefer appeals , to make applications or petitions , and to give affidavits , wherever necessary and to defend or compound , compromise , abandon , submit to arbitration or otherwise settle any suit ,action, claim , legal proceedings , appeal , demand or dispute relating to the trust matters.
- xxiii. To apply the whole or any part of the Trust Fund (Corpus and/ or income) or property for the objects and purposes of the trust and to set apart the whole or part of the income of the Corpus or Part thereof for any of the objects of the Trust.
- xxiv. - .xxv. Further the books of accounts of the Trust will be audited by a qualified accountant.

The accounting period of the trust shall be from 1st April to 31st March, however the period may be changed by the Trustees by passing appropriate resolution by 2/3 majority at General Body meeting of the Trust.

21. **OPERATION OF BANK ACCOUNT:**

- b. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.

28. **DISSOLUTION:**

The Trust hereby created is **irrevocable**. However, if for any reason this trust fails or it is resolved to dissolve this Trust at any future time, the trustees shall transfer all the assets and liabilities, properties, institutions and Fund to charitable trust or Society whose objects are similar to those of this Trust and which enjoys recognition U/s 80G of Income Tax Act, 1961 as amended from time to time. The Assets remaining as on the date of dissolution of the Trust shall under no circumstances be distributed among the Trustees.




